Note of interview between the Minister for Justice and the British Ambassador at 4.15 p.m. on Friday 10th July 1970.

> Subject: Incursion by British troops from across the Border.

The Ambassador was introduced by Mr. Ó Gallchobhair of the Political Division of the Department of External Affairs. The Secretary of the Department of Justice was in attendance.

The Minister expressed his concern to the Ambassador at the frequency with which British troops were coming into the Twenty-six Counties in recent months, sometimes questioning residents at gun-point and the Minister went on to say that local residents, in particular, had expressed such strong resentment that the Minister thought it well to advise the Ambassador that a repetition might give rise to an untoward incident which would be a matter of regret by all. The Minister mentioned, in reply to the Ambassador, that there had been seven separate incidents in respect of which he had received police reports and that local rumours were to the effect that there were many more such incidents.

The Ambassador enquired if the Minister's expression was in the nature of a formal protest and if his visit would be the subject of a statement and the Minister replied that it was not his intention to issue any statement but that it is intention to a Question in that regard in the Dáil on Tuesday or Wednesday (14th or 15th July), to say that he had seen the Ambassador and had drawn his attention to the matter.

At the Ambassador's request the Minister undertook to send him particulars of the 7 incidents.
