The attached note from the French Embassy requests our assistance in the matter of the taking of evidence from Miss Cecilia Moore in connection with the disappearance of Seamus Ruddy. The French authorities say that their investigation established that Ruddy was a member of the IRSP until he resigned at the end of 1983. He arrived in France in 1984 and was employed as a teacher of English. Miss Moore told the French that Ruddy had not been seen since 9 May 1985. From a reading of the press, the French understand that Miss Moore alleges that the INLA were responsible for his disappearance, that a member of the INLA in France (whose identity she knows) had the key to Ruddy's appartment which he gave back to the landlord and that this person had told her that Ruddy had been brought back to Ireland for an interrogation. In May 1985 a bag containing blood-stained garments was found and in September of that year a connection was established between the clothing and Ruddy's disappearance.

The French Embassy note was received in the Department in the middle of December of last year. It was brought to my attention for the first time yesterday. It was originally sent to Consular who passed it on to Anglo-Irish. We asked the Embassy to provide a translation. At first the Embassy said they had sent one but later they accepted that we had not received it and undertook to send us a copy. We still have not received it.
