ELEVENTH AMENDMENT OF THE CONSTITUTION BILL, 1990

BILL

entitled

AN ACT TO AMEND THE CONSTITUTION.

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed to amend Articles 2 and 3 of the Constitution:

BE IT THEREFORE ENACTED BY THE OIREACHTAS AS FOLLOWS:

1. Article 2 of the Constitution is hereby amended as follows:

- (a) The Article set out in Part I of the Schedule to this Act shall be substituted for Article 2 of the Irish text,
- (b) The Article set out in Part II of the Schedule to this Act shall be substituted for Article 2 of the English text.

2. Article 3 of the Constitution is hereby amended as follows:

- (a) The Article set out in Part III of the Schedule to this Act shall be substituted for Article 3 of the Irish text,
- (b) The Article set out in Part IV of the Schedule to this Act shall be substituted for Article 3 of the English text.

3. (1) The amendment of the Constitution effected by this Act shall be called the Eleventh Amendment of the Constitution.  
(2) This Act may be cited as the Eleventh Amendment of the Constitution Act, 1990.

AN ACT TO AMEND THE CONSTITUTION:

WHEREAS by virtue of Article 46 of the Constitution any provision 5  
of the Constitution may be amended in the manner provided by that  
Article:

AND WHEREAS it is proposed to amend Articles 2 and 3 of the  
Constitution:

BE IT THEREFORE ENACTED BY THE OIREACHTAS AS 10  
FOLLOWS:

1.—(1) The Article set out in *Part I* of the Schedule to this Act  
shall be substituted for Article 2 of the Irish text of the Constitution.

(2) The Article set out in *Part II* of the Schedule to this Act shall  
be substituted for Article 2 of the English text of the Constitution. 15

2.—(1) The Article set out in *Part III* of the Schedule to this Act  
shall be substituted for Article 3 of the Irish text of the Constitution.

(2) The Article set out in *Part IV* of the Schedule to this Act shall  
be substituted for Article 3 of the English text of the Constitution.

Citation.

3.—(1) The amendment of the Constitution effected by this Act 20  
shall be called the Eleventh Amendment of the Constitution.

(2) This Act may be cited as the Eleventh Amendment of the  
Constitution Act, 1990.
