'SAYS NO' BANNERS

- The purpose of this submission is to advise you of action which we intend to take as a result of the continuing display without consent of 'Says No' banners around the Province.
- The 3-month consent given under the Control of Advertisement Regulations 1973 for the display of these banners has now expired in all cases. The attached schedule shows the present position with banners on display in 15 of the 26 Council areas.
- 3. In 5 areas Councils have submitted applications for consent to further display and these have been refused in 2 cases for the reason that permanent display would be unsatisfactory on visual amenity grounds. Refusals for the same reason will issue in the other cases where applications have been received. Applicants have the right of appeal to the Planning Appeals Commission against refusals but to date no appeals have been lodged. If no appeal is lodged and the banner is not removed, the Councils concerned could be liable for fines of up to £1,000 plus a daily fine of £20 if we take action through the Courts. However I propose to follow our normal procedure and in the first instance ask the responsible parties to remove the breaches. To this end it is intended to write to the Clerk of offending Councils drawing their attention to the breaches and asking to-be advised of the action which is proposed to remedy these.
- 4. When we have responses from the Councils, I will advise you further.
