PROPERTIES OCCUPIED BY SINN FEIN

You will recall that DOE lets us have regular information about properties occupied by Sinn Fein. I attach a copy of Mr Hamilton's note of 16 June which gives some interesting information about DOE owned properties on the Shankill Road. The use of the properties listed at paragraph 5 seems particularly worrying and it could be very embarrassing if it ever became public knowledge that government was the owner of premises at which weapons were found. I would be glad of your views on this: at the very least DOE should be encouraged to press ahead with possession as quickly as possible even if it meant that the site was left vacant for some time.

TENANCIES OF DOE PROPERTY ON SHANKILL ROAD, BELFAST

- 1. This Department continues to own much of the Shankill Road commercial frontage which it acquired from NIHE in the late 1970s. Our tenants are for the most part shopkeepers, but 4 of our properties are occupied by organisations whose names or activities suggest that they might bear further investigation to ensure that our remaining their landlord is consistent with current policy. In particular there may be security implications. All are our legitimate tenants and pay their rent regularly.
- 2. Information on each is below. I should be grateful if you could arrange for the appropriate advice to be obtained.
- 3. 200A Shankill Road Tenant: Mr James McDonald

These premises are shared by Alderman Hugh Smyth, who has an Advice Centre, and the Loyalist Prisoners Welfare Association.

The property occupies part of a site which we expect to need in the next year or so for new development by Belfast Co-operative Society Limited with whom we are in active negotiations. In turn we are in touch with Mr Smyth about relocation of the occupants to a vacant shop in our ownership also on Shankill Road. This would involve some repair work at DOE expense to prepare the vacant premises for the new tenants. In itself, this would be a legitimate management expense, but it could be made to appear that we were doing the work for the benefit of the 2 organisations concerned.

4. 182 Shankill Road - Tenant: North Belfast Mutual Association

This is the Shankill Black Taxi organisation. We have no plans to redevelop the site and are in touch with the Association about the possibility of their buying the property.

5. <u>9-11 Downing Street - Tenant: Ulster Loyalist Sports and Social Club</u> 4-8 Craven Street - Tenant: Shankill Sports Social and Recreation Club

These are both licensed clubs. We are considering proposals for the longer term redevelopment of the site for new housing but we would be unlikely to be seeking possession before 1990/91. The security forces recently found weapons in the Craven Street premises.
