EU SPECIAL SUPPORT PROGRAMME FOR PEACE AND RECONCILIATION: LETTER OF 26 MARCH FROM MR NICHOLSON, MEP

- 1. Mr Jim Nicholson, MEP wrote to you on 26 March enclosing a letter from the Secretary of LOL No 978, Ormeau Apprentice Boys' Temperance, which sought further details about a grant paid from the EU Special Support Programme for Peace and Reconciliation to the Lower Ormeau Community.
- A grant to the Lower Ormeau Residents' Action Group has 2. recently been approved under Measure 1 of the Social Inclusion Sub-programme of the Peace Programme. The grant is for a total of £60,000 (£20,000 for each of 3 years), including European and matching funding. It has been approved to cover the costs of a community development officer (salary and costs of development activities).
- This Measure is managed by the Northern Ireland Voluntary 3. Trust (one of the 6 Intermediary Funding Bodies) and it is for them to justify their decision in the first instance. On the question of eligibility, it seems that the project falls clearly within the terms of the Measure as laid down in the Programme document and is consistent with the objectives of the Measure. The employment of

community development officers to undertake capacity training in communities where such capacity does not presently exist is also included in the description of types of action which are eligible.

4. DHSS is the accountable Department for this Measure and I have cleared the attached draft response to Mr Nicholson with them.

FUNDING TO LOWER ORMEAU COMMUNITY

Thank you for your letter of 26 March 1996 enclosing correspondence from Mr Stephen Cousins, Secretary of the Ormeau Apprentice Boys' Temperance, about the funding of the Lower Ormeau Community under the EU Special Support Programme for Peace and Reconciliation.

A grant of £60,000 to the Lower Ormeau Residents' Action Group has been approved under Measure 1 (Developing Grass Roots Capacities and Promoting the Inclusion of Women) of the Social Inclusion Sub-programme of the Peace Programme. One of the objectives of this Measure is to build trust, capacities and skills within communities to initiate and facilitate the development of their own areas with a view to enabling them to participate in cross-community activity in the longer term. In this case, the grant is for the employment of a community development officer and will cover salary costs as well as the costs of running training courses etc for local groups. This

is consistent with the types of action which are eligible under the Measure.

The decision on funding was taken by the Northern Ireland

Voluntary Trust (NIVT), which is the Intermediary Funding Body

responsible for the management of this Measure and I suggest

that Mr Cousins should contact them directly at
