Report says that families should have an apology

The relatives of the 15 men, women and children who suffered horrendous deaths in the McGurk's atrocity deserve an apology the HET said.

Long overdue

And while the families believe this is long overdue, the report fails to state clearly who they should receive the apology from.

The report also finds no evidence of collusion despite a wealth of information.

The daughter of James Smyth, Margaret McCready and her husband Tommy, said the report was hard to fathom.

"The HET say we the families deserve an apology but don't say who from. The media reports were completely wrong about the bomb. It was black propaganda," Tommy said.

"They say they don't have any evidence of collusion, but there is enough circumstantial evidence here to support that. To me this was collusion, there's no doubt in my mind."

The wife of Edward Kane, Bridget said the report raised more questions than answers for her.

Tiger

"I think the HET is a tiger without teeth. They can't compel or force anybody to take part in any enquiry. It's what the report doesn't say that stands out for me."

Patsy McNally son-in-law of Francis Bradley said he was disappointed.

"At the time the people who died were regarded as IRA supporters, people said they were sorry about the bomb but discriminated against them too. I

"I wondering did they get any help from fiction author Roal Dahl on this because what they're basically saying my mother died because the army had to be taken off the streets to get their tea. It's just plain silly."

Pacelli (Prescilla) Clarke, sister of Robert Charles Spotswood said she found the report very emotional but queried why so much evidence had been lost.

Missing

"How come all the evidence went missing? As it stands they can't prove anything without it. I don't think it's going to come to anything if they don't have that."
